Overall Analysis:
Baby Raunak Kumar was brought to the hospital on the morning of 3rd March 2019 by his parents. He suffered internal head injury because of a fall from 1st floor of a house, which is approx. 12ft high from the ground. We have kept him under observation currently in NICU under intermittent oxygen inhalance, 2-3 hourly drug coverage and medical supervision. He will be in NICU for 7 to 8 days and post that patient will be shifted to General ward till complete recovery.

Parents are not able to sustain the cost of this unplanned medical expense hence seek support from organizations/individuals for his treatment and full recovery.
